YOUR RIGHTS

1. WHO PROCESSES YOUR DATA?

2. WHAT DATA DOES THE WEBSITE PROCESS?

Browsing data. These are **data transmitted in the use of internet communication protocols** , which are collected by hardware devices and software procedures to support the site. This data includes IP addresses,

domain names requested by the terminals used by users, information on which pages have been visited or other parameters relating to the operating system and the user's IT environment.

3. WHAT IS THE LEGAL BASIS AND PURPOSE OF THE PROCESSING?

Browsing data are processed on the basis of a **legitimate interest** of the Owner for the purpose of ensuring the correct and efficient functioning of the web pages.

4. HOW LONG WILL THE DATA BE KEPT?

Browsing data will be stored for a maximum of 3 months.

5. TO WHOM ARE YOUR DATA COMMUNICATED?

Exclusively for the purposes indicated above, your data may be transmitted to the figures indicated below:

- **Data Processors** - are **third parties who process data on our behalf** , who guarantee adequate security measures in order to best protect your information;
- **Data controllers** – these are **employees or internal collaborators** who have received a specific appointment and training to process data according to their duties;
- **Recipients of the processing** - are professionals or companies that receive communications of personal data from the Owner, but who, following such communication, act as independent Owners. Among these: **Google Maps**. When you access Google Maps to have more information on the location of our facility, we remind you that you will be subject to Google's privacy policies.
